Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

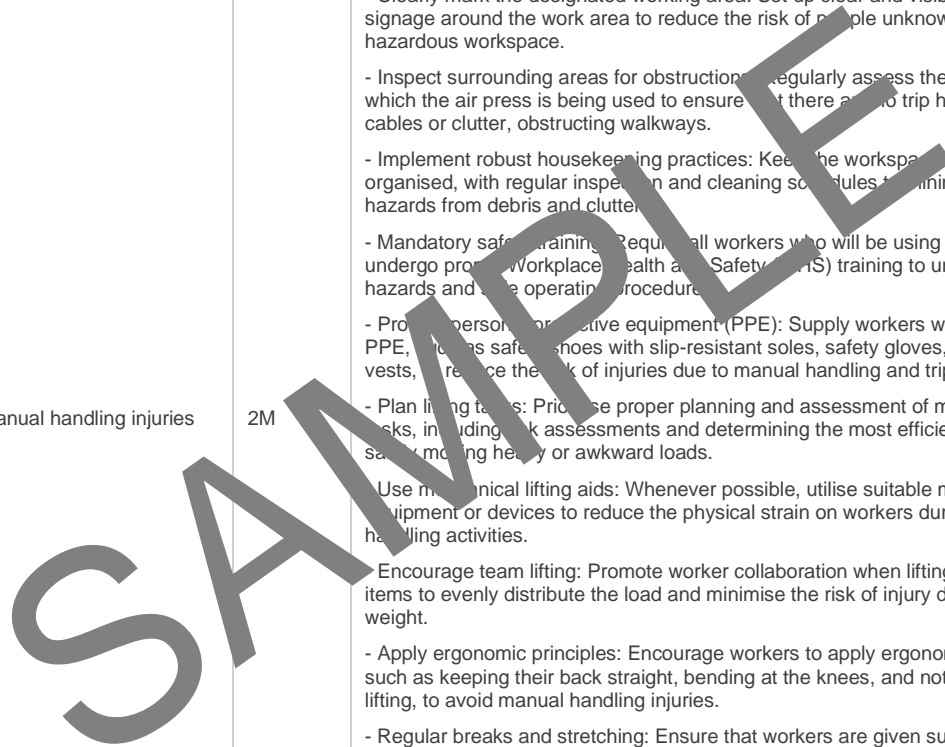

Note: A SWMS must be reviewed regularly to make sure it remains effective. A SWMS must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Trip hazards, manual handling injuries	2M	<ul style="list-style-type: none"> - Clearly mark the designated working area: Set up clear and visible barriers or signage around the work area to reduce the risk of people unknowingly entering a hazardous workspace. - Inspect surrounding areas for obstructions: Regularly assess the environment in which the air press is being used to ensure that there are no trip hazards, such as cables or clutter, obstructing walkways. - Implement robust housekeeping practices: Keep the workspace clean and well-organised, with regular inspection and cleaning schedules to minimise the risk of trip hazards from debris and clutter. - Mandatory safety training: Require all workers who will be using the air press to undergo proper Workplace Health and Safety (WHS) training to understand potential hazards and safe operating procedures. - Provide personal protective equipment (PPE): Supply workers with appropriate PPE, including safety shoes with slip-resistant soles, safety gloves, and high-visibility vests, to reduce the risk of injuries due to manual handling and tripping. - Plan lifting tasks: Prioritise proper planning and assessment of manual handling tasks, including task assessments and determining the most efficient method of safely moving heavy or awkward loads. - Use mechanical lifting aids: Whenever possible, utilise suitable mechanical lifting equipment or devices to reduce the physical strain on workers during manual handling activities. - Encourage team lifting: Promote worker collaboration when lifting large or heavy items to evenly distribute the load and minimise the risk of injury due to excessive weight. - Apply ergonomic principles: Encourage workers to apply ergonomic best practices, such as keeping their back straight, bending at the knees, and not twisting while lifting, to avoid manual handling injuries. - Regular breaks and stretching: Ensure that workers are given sufficient breaks during work, and encourage them to perform simple stretches to alleviate muscle tension from repetitive tasks. - Monitor and review control measures: Regularly evaluate the implemented control measures' effectiveness through inspections and worker feedback, making adjustments as necessary to improve safety in the workspace. 	1L

			<ul style="list-style-type: none"> - Qualified personnel: Only allow trained and certified staff members to carry out equipment inspections and maintenance tasks. - Personal Protective Equipment (PPE): Ensure that workers wear appropriate PPE such as safety gloves, insulated shoes, safety glasses, and any other necessary protective gear during equipment inspection. - Visual assessment: Before starting work, workers should visually assess the equipment for visible defects, frayed cables or signs of damage. - Check electrical connections: Inspect the electrical connections around the air press equipment to make sure there are no loose or exposed wires. - Ground Fault Circuit Interrupters (GFCIs): Install and use GFCIs on power sources to provide additional protection against electrical shock hazards. - Safe handling practices: Train employees on proper lifting and maneuvering techniques to avoid dropping or causing damage to equipment during inspections. - Adequate lighting: Make sure the inspection area is well-lit to facilitate easy identification of potential hazards and damages. - Isolate damaged equipment: If any equipment is found to be damaged during inspection, it should be immediately removed from service and tagged as 'Do Not Use' until repairs can be made. - Repair protocols: Establish detailed repair instructions and protocols for damaged equipment, ensuring that only skilled technicians carry out the necessary repairs. - Recordkeeping: Maintain accurate records of equipment inspections, identified hazards, control measures taken, and any repairs or maintenance activities conducted. This allows you to track trends and address recurring issues proactively.

			<ul style="list-style-type: none"> - Noise barriers: Where feasible, install temporary noise barriers or screens to reduce noise exposure within the work area. - Work procedures: Provide written work procedures and guidelines, and ensure that all workers are trained and competent in their respective tasks to minimise potential hazards. - Communication methods: Implement efficient communication methods, such as two-way radios, hand signals, or established work codes, to alert workers about possible safety risks in the work area. - Rotate workers: Minimise prolonged exposure to noise hazards by rotating workers regularly between different tasks and work areas. - Housekeeping: Maintain a clean and organised work area by removing debris, waste material, and unused tools or equipment. SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
