Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

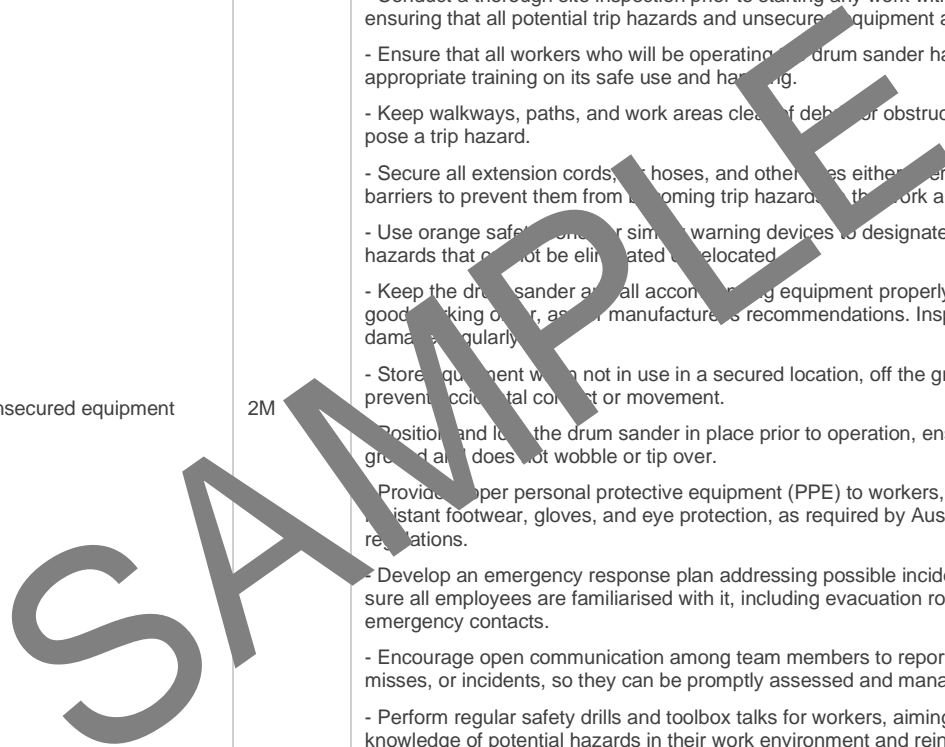

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Trip hazards, Unsecured equipment	2M	<ul style="list-style-type: none"> - Conduct a thorough site inspection prior to starting any work with the drum sander, ensuring that all potential trip hazards and unsecured equipment are identified. - Ensure that all workers who will be operating the drum sander have received appropriate training on its safe use and handling. - Keep walkways, paths, and work areas clear of debris or obstructions that could pose a trip hazard. - Secure all extension cords, hoses, and other cables either overhead or behind barriers to prevent them from becoming trip hazards in the work area. - Use orange safety cones or similar warning devices to designate potential trip hazards that cannot be eliminated or relocated. - Keep the drum sander and all accompanying equipment properly maintained and in good working order, as per manufacturer's recommendations. Inspect for defects or damage regularly. - Store equipment when not in use in a secured location, off the ground if possible, to prevent accidental contact or movement. - Position and lock the drum sander in place prior to operation, ensuring it is on even ground and does not wobble or tip over. - Provide proper personal protective equipment (PPE) to workers, such as slip-resistant footwear, gloves, and eye protection, as required by Australian WHS regulations. - Develop an emergency response plan addressing possible incidents, and make sure all employees are familiarised with it, including evacuation routes and emergency contacts. - Encourage open communication among team members to report hazards, near-misses, or incidents, so they can be promptly assessed and managed accordingly. - Perform regular safety drills and toolbox talks for workers, aiming to refresh their knowledge of potential hazards in their work environment and reinforce preventative measures. - Conduct ongoing hazard assessments and implement any new necessary control measures, regularly updating the SWMS as appropriate. This ensures an adaptable approach to maintaining a safe workplace while using the drum sander. 	1L

			<ul style="list-style-type: none"> - Inspect the drum sander's emergency stop button and any safety interlocks for proper functioning, testing them to ensure they quickly deactivate the machine as intended. - Verify that the drum sander is properly grounded to minimise the risk of electrical shock. - Examine the work area for sufficient lighting and clear access to the equipment, removing any trip hazards or obstructions near the drum sander. - Arrange for routine maintenance checks by qualified technicians who can assess the overall condition of the machine and identify any early signs of degradation or malfunction. - Establish a system for employees to regularly report any concerns or issues with the drum sander promptly so they can be resolved before causing harm. - Ensure all personnel operating the drum sander are adequately trained in its safe usage including wearing appropriate personal protective equipment (PPE) such as eye protection and hearing protection. - Use only manufacturer approved replacement parts when performing repairs or regular maintenance on the drum sander to maintain its structural integrity and safety performance. - Implement lockout/tagout procedures when performing maintenance or repairs on the drum sander to prevent potential exposure to electrical hazards. - Keep a well-stocked first aid kit readily available near the work area to address any potential injuries sustained while operating the drum sander promptly. - Review and update the Safe Work Method Statement (SWMS) regularly to ensure all hazard control measures remain relevant and effective in mitigating risks associated with the inspection and use of the drum sander.

Power Connection	Electric shock, Faulty grounding	3H	<ul style="list-style-type: none"> - Ensure all electrical equipment, including the drum sander, is inspected and tested by a licensed professional regularly to check for signs of wear or damage. - Verify that power cords are free from cuts, frays, or exposed wires, and replace them if necessary. - Utilise RCD (Residual Current Device) or safety switches in all power outlets connected to the drum sander to minimise the risk of electric shock. - Make sure that staff operating the drum sander is trained in the correct use of the machine, including power connection procedures, safe working practices, and recognizing potential hazards. - Regularly inspect grounding connections for proper securement and contact on the drum sander and power source to prevent faulty grounding. - Set up a designated, secure area for connecting and disconnecting the drum sander to reduce the chance of unauthorised users tampering with the machinery. 	1L

			<ul style="list-style-type: none"> - Ensure workers are wearing appropriate personal protective equipment (PPE), such as insulated gloves and rubber-soled shoes, when connecting or disconnecting the drum sander. - Establish clear communication channels between staff involved in the operation of the drum sander to report any issues with the machinery promptly. - Make certain emergency shutdown procedures are clearly defined, understood by all members of the team, and practiced periodically. Workers should be prepared for potential situations involving electrical hazards. - Maintain strict adherence to local and national regulations regarding electrical safety, and ensure all appropriate permits are obtained before commencing work. - Develop and maintain an up-to-date SWMS (Safe Work Method Statement) for the operation of the drum sander, specifically including policies and procedures surrounding power connection tasks, and organise regular training and refresher courses for staff.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
