Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

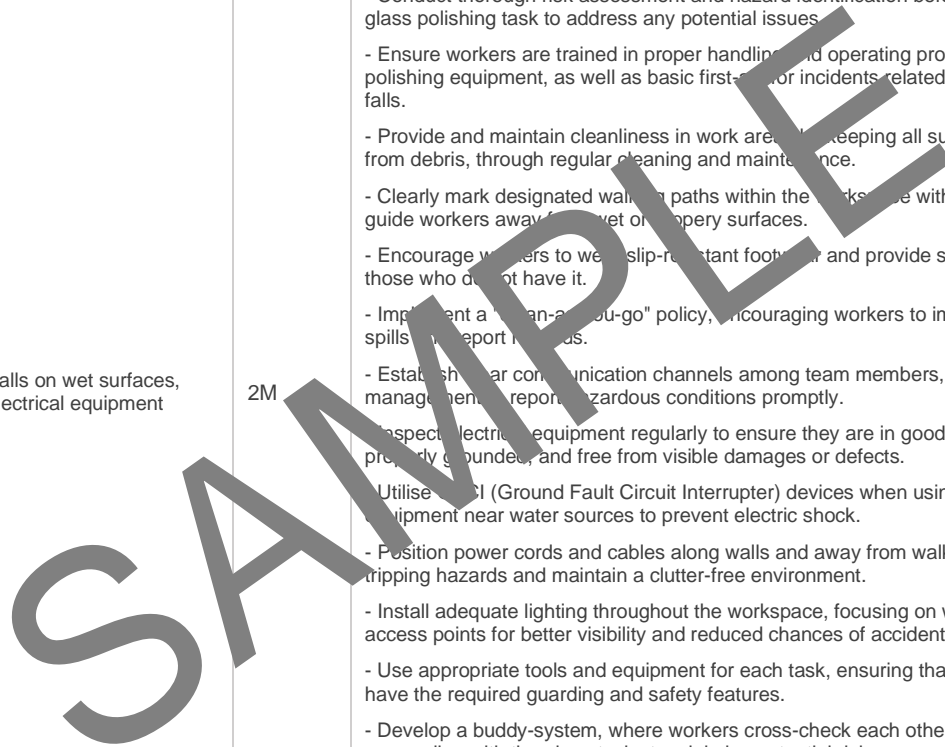

**Note:** A SWMS must be reviewed regularly to make sure it remains effective. A SWMS must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Slips, trips and falls on wet surfaces, Unsafe use of electrical equipment	2M	<ul style="list-style-type: none"> <li>- Conduct thorough risk assessment and hazard identification before starting the glass polishing task to address any potential issues.</li> <li>- Ensure workers are trained in proper handling and operating procedures of glass polishing equipment, as well as basic first-aid for incidents related to slips, trips, and falls.</li> <li>- Provide and maintain cleanliness in work areas, keeping all surfaces dry and free from debris, through regular cleaning and maintenance.</li> <li>- Clearly mark designated walking paths within the workspace with caution signs to guide workers away from wet or slippery surfaces.</li> <li>- Encourage workers to wear slip-resistant footwear and provide suitable footwear to those who do not have it.</li> <li>- Implement a "clean-as-you-go" policy, encouraging workers to immediately clean spills and report hazards.</li> <li>- Establish clear communication channels among team members, supervisors, and management to report hazardous conditions promptly.</li> <li>- Inspect electrical equipment regularly to ensure they are in good working order, properly grounded, and free from visible damages or defects.</li> <li>- Utilise RCD (Ground Fault Circuit Interrupter) devices when using electrical equipment near water sources to prevent electric shock.</li> <li>- Position power cords and cables along walls and away from walkways to minimise tripping hazards and maintain a clutter-free environment.</li> <li>- Install adequate lighting throughout the workspace, focusing on walkways and access points for better visibility and reduced chances of accidents.</li> <li>- Use appropriate tools and equipment for each task, ensuring that all machines have the required guarding and safety features.</li> <li>- Develop a buddy-system, where workers cross-check each other's setup before proceeding with the given tasks to minimise potential risks.</li> <li>- Schedule regular meetings to discuss lesson learned, incidents and implement continuous improvement in workplace health and safety practices.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Enforce a "clean-as-you-go" policy to maintain a safe and organised work environment, immediately disposing of any glass debris in designated containers.</li> <li>- Utilise adequate and ergonomically designed tools such as glass inspection lights and magnifiers, to reduce eye strain.</li> <li>- Schedule regular breaks for workers during the glass inspection process to prevent eye fatigue and repetitive motion injuries.</li> <li>- Encourage workers to take advantage of vision screening programs or provide resources for eye examinations and proper eyewear for those who may require it.</li> <li>- Develop a report system for damaged or improperly used glass and ensure all workers are aware and follow the procedures.</li> <li>- Establish an emergency response plan, including first-aid kits and trained personnel, to address any accidents resulting in cuts or eye injuries promptly and effectively.</li> <li>- Conduct comprehensive job hazard analysis for each stage of the glass polishing process to identify new hazards and update control measures accordingly.</li> <li>- Create a culture of open communication where workers feel comfortable reporting hazards or concerns about their work environment.</li> <li>- Regularly review and update the Safe Work Method Statements (SWMS) for glass polishers to reflect industry best practices and changes in workplace laws and regulations.</li> </ul>

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
