Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

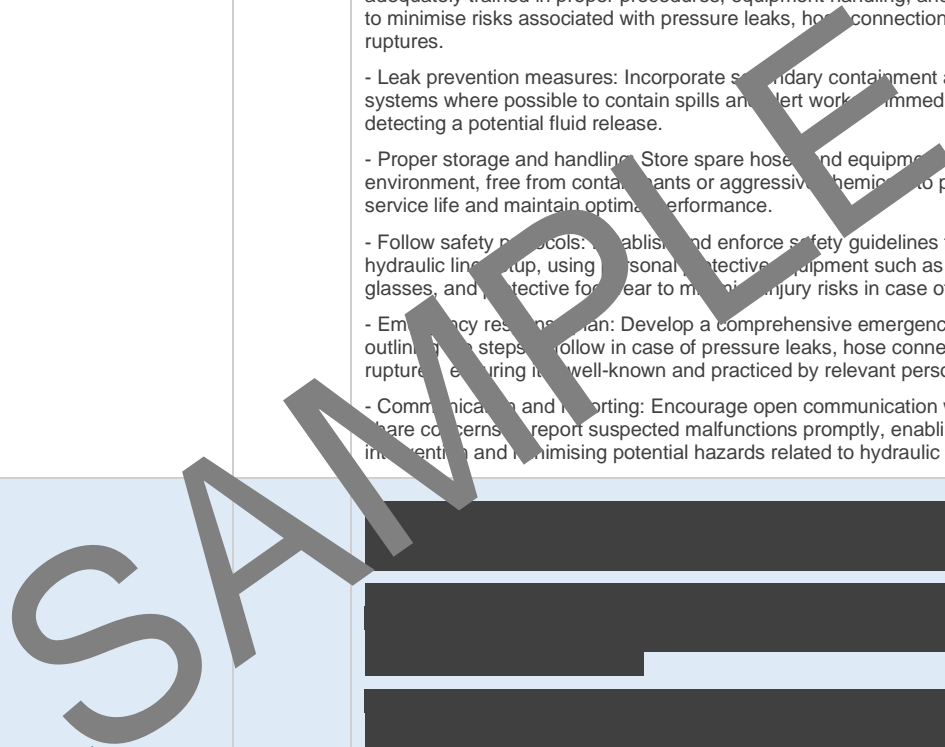
When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Manual handling hazards, Exposure to hydraulic fluids, Slips and trips	3H	<ul style="list-style-type: none"> <li>- Provide all workers with appropriate manual handling training, including safe lifting techniques, to reduce the risk of injuries due to incorrect handling practices.</li> <li>- Ensure that the work area is kept clean and tidy at all times, with clear access paths to reduce the likelihood of slips, trips and falls.</li> <li>- Inspect the hydraulic punch and shear equipment regularly to identify any leaks or weaknesses in the hydraulic system, repairing or replacing components as necessary to prevent accidents caused by fluid exposure.</li> <li>- Store hydraulic fluids in clearly labelled containers and ensure they are sealed securely when not in use to minimise the risk of accidental spills.</li> <li>- Use appropriate personal protective equipment (PPE) for workers, such as gloves, safety glasses and steel-toe boots, to protect them from potential hazards when handling hydraulic fluids and operating machinery.</li> <li>- Implement a regular maintenance schedule for the hydraulic punch and shear equipment ensuring all components are in good working condition and serviced as required to prevent potential hazards.</li> <li>- Utilise dollies or lifting devices to help transport heavy objects, minimising the need for manual handling and reducing the risk of strain-related injuries.</li> <li>- Apply anti-slip flooring or mats to high-traffic areas where there may be an increased risk of slips and trips, especially around the hydraulic punch and shear machine.</li> <li>- Establish designated waste disposal areas for excess hydraulic fluid, ensuring proper containment measures are in place to prevent environmental contamination and other hazards.</li> <li>- Implement warning signage near the hydraulic punch and shear equipment to alert workers of potential hazards and reminding them to follow safe operating procedures.</li> <li>- Clearly mark and adhere to load-bearing limits for the hydraulic punch and shear equipment, which will minimise the risk of overloading and potential equipment failure.</li> <li>- Encourage open communication among workers regarding potential hazards and issues, ensuring all concerns are promptly addressed and resolved to maintain a safe working environment.</li> </ul>	2M

			<ul style="list-style-type: none"> <li>- Train employees on the proper inspection and operation procedures of hydraulic punch and shear machines, including recognizing potential hazards and applying safe work practices.</li> <li>- Establish lockout/tagout procedures to isolate the hydraulic punch and shear machine's energy sources, preventing unexpected start-ups during inspection.</li> <li>- Use personal protective equipment (PPE) such as gloves, safety glasses, and steel-toed boots when inspecting the equipment to minimise potential injuries from sharp edges or pinch points.</li> <li>- Inspect all hoses, fittings, and connections for leaks, wear, or damage before operating the hydraulic punch and shear machine.</li> <li>- Make sure the work area is clear of debris, unnecessary equipment, or obstructions that may cause trips, slips, or falls during the inspection process.</li> <li>- Before beginning the inspection, review the equipment's manual to fully understand its proper operation, maintenance requirements, and potential hazards.</li> <li>- Ensure employees maintain a safe distance from moving machine parts during inspection to avoid injury due to pinch points or faulty components.</li> <li>- Replace damaged or worn parts immediately and do not operate the hydraulic punch and shear machine until all necessary repairs have been made.</li> <li>- Document and maintain records of all inspections, repairs, and maintenance activities performed on the hydraulic punch and shear machine.</li> <li>- Foster an open communication environment where employees feel empowered to report any hazardous conditions or concerns regarding the equipment's functionality.</li> <li>- Regularly conduct workplace safety audits to identify potential hazards and opportunities for improvement in the equipment's operation and maintenance processes.</li> </ul>

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
