Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct a risk assessment of those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

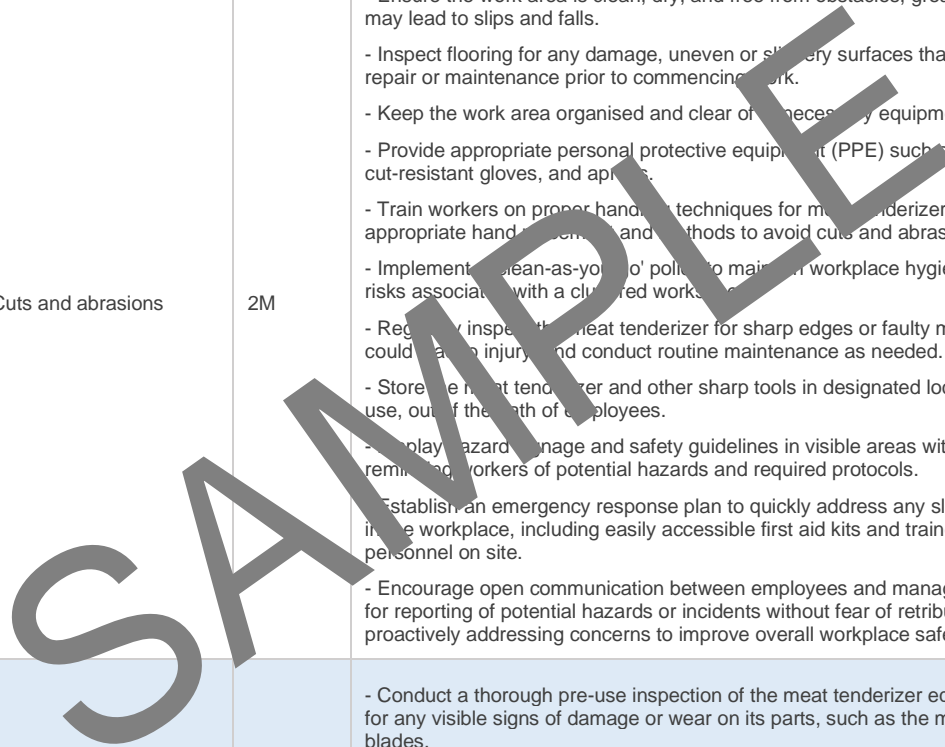

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

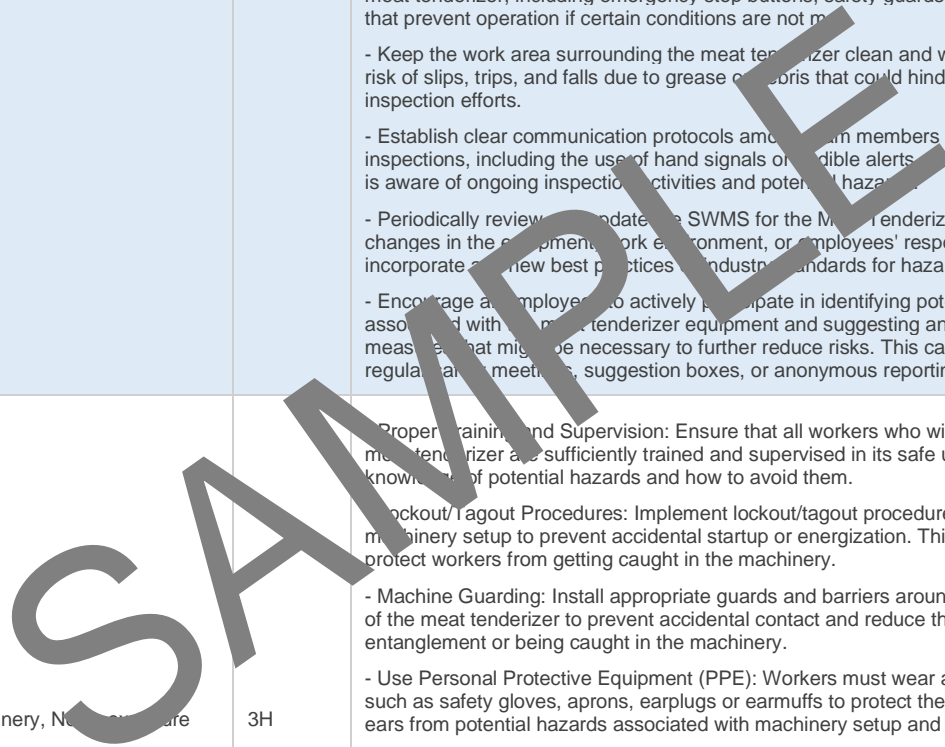
When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Slips and falls, Cuts and abrasions	2M	<ul style="list-style-type: none"> <li>- Ensure the work area is clean, dry, and free from obstacles, grease or oil which may lead to slips and falls.</li> <li>- Inspect flooring for any damage, uneven or slippery surfaces that may require repair or maintenance prior to commencing work.</li> <li>- Keep the work area organised and clear of unnecessary equipment and tools.</li> <li>- Provide appropriate personal protective equipment (PPE) such as non-slip shoes, cut-resistant gloves, and aprons.</li> <li>- Train workers on proper handling techniques for meat tenderizers, including appropriate hand placement and methods to avoid cuts and abrasions.</li> <li>- Implement a 'clean-as-you-go' policy to maintain workplace hygiene and minimise risks associated with a cluttered workspace.</li> <li>- Regularly inspect the meat tenderizer for sharp edges or faulty mechanisms that could lead to injury and conduct routine maintenance as needed.</li> <li>- Store the meat tenderizer and other sharp tools in designated locations when not in use, out of the reach of employees.</li> <li>- Display hazard signage and safety guidelines in visible areas within the workspace, reminding workers of potential hazards and required protocols.</li> <li>- Establish an emergency response plan to quickly address any slips, falls, or injuries in the workplace, including easily accessible first aid kits and trained medical personnel on site.</li> <li>- Encourage open communication between employees and management, allowing for reporting of potential hazards or incidents without fear of retribution, and proactively addressing concerns to improve overall workplace safety.</li> </ul>	1L	
2. Equipment Inspection	Malfunctioning equipment, Electrical hazards	2M	<ul style="list-style-type: none"> <li>- Conduct a thorough pre-use inspection of the meat tenderizer equipment, checking for any visible signs of damage or wear on its parts, such as the motor, casing, and blades.</li> <li>- Ensure that all electrical connections, including power cords, plugs, and sockets, are in good condition and free from frayed wires, exposed wiring, or damaged insulation which could cause electrical hazards.</li> <li>- Implement a regular maintenance schedule for the meat tenderizer equipment to reduce the risk of malfunctioning components. This includes cleaning, lubricating, and servicing the machine according to the manufacturer's guidelines.</li> <li>- Provide proper training to employees responsible for operating the meat tenderizer, covering safe usage, hazard identification, and emergency procedures in case of an equipment malfunction.</li> <li>- Ensure that employees wear appropriate personal protective equipment (PPE) during equipment inspections, such as gloves, safety glasses, and close-toed shoes, to protect against potential injuries from sharp edges and moving parts.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Verify the correct functioning of all safety features and mechanisms built into the meat tenderizer, including emergency stop buttons, safety guards, and interlocks that prevent operation if certain conditions are not met.</li> <li>- Keep the work area surrounding the meat tenderizer clean and well-lit, reducing the risk of slips, trips, and falls due to grease or debris that could hinder equipment inspection efforts.</li> <li>- Establish clear communication protocols among team members during equipment inspections, including the use of hand signals or audible alerts. Ensure everyone is aware of ongoing inspection activities and potential hazards.</li> <li>- Periodically review and update the SWMS for the Meat Tenderizer to reflect any changes in the equipment, work environment, or employees' responsibilities and incorporate any new best practices or industry standards for hazard control.</li> <li>- Encourage all employees to actively participate in identifying potential hazards associated with the meat tenderizer equipment and suggesting any additional control measures that might be necessary to further reduce risks. This can be done through regular team meetings, suggestion boxes, or anonymous reporting systems.</li> </ul>		
3. Machinery Setup	Caught in machinery, Noise exposure	3H	<p>Proper Training and Supervision: Ensure that all workers who will be operating the meat tenderizer are sufficiently trained and supervised in its safe use, including knowledge of potential hazards and how to avoid them.</p> <p>Lockout/Tagout Procedures: Implement lockout/tagout procedures during the machinery setup to prevent accidental startup or energization. This will help to protect workers from getting caught in the machinery.</p> <ul style="list-style-type: none"> <li>- Machine Guarding: Install appropriate guards and barriers around the moving parts of the meat tenderizer to prevent accidental contact and reduce the risk of entanglement or being caught in the machinery.</li> <li>- Use Personal Protective Equipment (PPE): Workers must wear appropriate PPE such as safety gloves, aprons, earplugs or earmuffs to protect their hands, body and ears from potential hazards associated with machinery setup and noise exposure.</li> <li>- Inspect Machinery: Regularly inspect the meat tenderizer for any signs of wear or damage, and ensure that it is functioning correctly before use.</li> <li>- Noise Reduction Measures: Implement noise control measures, such as installing noise-absorbing panels or other sound-dampening materials around the work area to reduce noise exposure to workers.</li> <li>- Clear Workspace: Keep the area around the meat tenderizer clear of unnecessary equipment, tools, and other obstacles that could interfere with proper machinery setup or contribute to accidents.</li> <li>- Emergency Stop Button: Ensure that the meat tenderizer is equipped with an easily accessible emergency stop button or switch that allows employees to halt its operation immediately if necessary.</li> </ul>	2M

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
