Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct a risk assessment of those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Training should include correct operation procedures, use of personal protective equipment (PPE), and emergency response protocols. - Implement a strict maintenance schedule for the machine to guarantee that it consistently functions at optimal safety standards. Encourage workers to report unsafe conditions without fear of reprisal. - Consider implementing cut resistant gloves to protect against shearing injuries specifically. - Use a machine with an emergency stop button within reach of operators, allowing for quicker response times in case of emergency. - Promote safe work practices such as not forcing the machine or using tools for jobs they weren't designed for. Remind operators to always keep their hands clear of the machine while it's in operation.

Maintenance	Electrical hazard, falling equipment	3H	<ul style="list-style-type: none"> - Utilise isolation procedures when performing maintenance activities, this includes locking out and tagging the machine, ensuring it is disconnected from its power source before commencing any maintenance work. - Regularly inspect the shearing machine to identify any visible signs of wear, tear or damage that may pose a risk. - Implement a routine maintenance schedule for the shearing machine in accordance with the manufacturer's recommendations, which should include regular cleaning and lubrication. - Ensure only trained and competent individuals perform maintenance tasks on the machinery with demonstration of understanding both theoretical and practical aspects. - During maintenance, there should be adequate lighting to avoid mishaps due to poor visibility. - Use proper personal protective equipment such as safety gloves, safety glasses, and safety shoes during the maintenance process. - For heavy parts of the machine, employ mechanical aids or seek assistance to manually handle them to prevent injury from falling equipment. - Mandate the use of insulated tools for work on electrical components to provide added protection against electrical hazards. - Do not rush maintenance tasks. Allow sufficient time to complete tasks properly and safely. - Practice good housekeeping around the machine after maintenance, ensuring all tools are accounted for and that no stray items remain that could interfere with the machine's operation or cause accidents. - Following maintenance, review and verify functionality of the machine operation prior to turning back over for production. SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
