Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Protective Gear Inspection	Damaged PPE, Inadequate PPE	3H	<ul style="list-style-type: none"> - All workers must be provided with training on how to properly inspect their PPE for any signs of damage or wear and tear. - Use only approved and certified protective gear that complies with Australian safety standards. - Gloves, safety glasses, hearing protection and respiratory protection should always be worn during operation of the metal tube cutting machine. - Regular checks and maintenance on all protective gear need to be conducted. - Team members must report damaged or faulty PPE immediately, and it must be replaced before the worker continues with their tasks. - A designated safety officer should carry out periodic checks to ensure compliance with PPE usage. - No worker is allowed to operate the machine without the correct PPE as identified in the risk assessment. - If a piece of PPE is deemed inadequate an alternative must be provided that addresses the specific hazard. - Implement a 'stop work' policy if adequate PPE is not being used or if it's faulty. - Keep an inventory of all PPE and monitor its lifespan to replace it before it becomes ineffective. - Maintain clean and sanitary storage areas for protective gear to prevent deterioration or contamination. - Encourage an open communication platform where employees can raise concerns about PPE. - Perform regular audits and reviews to ensure effectiveness of control measures and make changes as necessary. 	1L

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.

SAFE WORK METHOD STATEMENT REVIEW CHECKLIST

This Safe Work Method Statement Review Checklist is to be followed and used upon initial development of the SWMS to help ensure that all steps have been adequately taken before work commences. Think of this document as an internal audit review checklist before commencing work, and may form part of a Toolbox Talk (safety meeting) and may be used as an opportunity for education and training.
