Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct a risk assessment of those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Equipment malfunction, Slipping or tripping	2M	<ul style="list-style-type: none"> - Conduct thorough equipment inspections and maintenance checks before each operation to ensure the oil filter crusher is in optimal working condition. - Ensure the oil filter crusher is placed on a solid level surface that can support the weight of the equipment and any applied force during the crushing process. - Provide adequate lighting to illuminate the work area so workers can easily navigate around the oil filter crusher and reduce the risk of slips and trips. - Keep the work area clean and clear of debris to minimise trip hazards. - Require workers to wear appropriate non-slip footwear to provide adequate traction while working around the oil filter crusher. - Train employees on proper loading and operation of the oil filter crusher to prevent overloading and other malfunctions that could lead to accidents. - Encourage regular breaks during crusher operation to help reduce ergonomic strain on employees, which can lead to injuries from slips and trips. - Establish a protocol on what to do in the event of an equipment malfunction or incident involving slip or trip, including a clear chain of notification and responsibility for team members. - Clearly label and communicate all emergency stop buttons and shut-off switches, ensuring employees are aware of their locations and functionality. - Develop standard operating procedures (SOPs) for the preparation phase, detailing the required steps, safety considerations, and personal protective equipment requirements. - Regularly monitor and review the effectiveness of control measures, adjusting and modifying them as needed based on new information or site conditions. - Post warning signs around the work area to make others aware of potential hazards and inform them of proper safety measures. - Consider employing spill containment systems, such as drip trays or temporary barriers, designed to contain any spills or leaks that might occur during the filter crushing process. - Supply workers with appropriate personal protective equipment (PPE), such as gloves and eye protection, to reduce the risk of injury when working with the oil filter crusher. 	1L

			<ul style="list-style-type: none"> - Clearly mark out designated work zones around the oil filter crusher with safety barriers or signs to prevent unauthorised or accidental access during operation. - Ensure all personnel involved in the crushing process are adequately trained in the use, maintenance, and potential hazards associated with the oil filter crusher. - Provide and enforce the use of appropriate Personal Protective Equipment (PPE) such as safety gloves, goggles, and steel-toe footwear for workers operating the crusher or handling crushed filters. - Install and use an emergency stop button or system, allowing personnel to quickly shut down the crusher in case of any emergencies or unexpected hazards. - Implement a lockout/tag-out procedure for the oil filter crusher to ensure it remains powered down while necessary maintenance is performed, preventing accidental activation. - Keep hands, fingers, and loose clothing away from any moving parts or pinch points of the oil filter crusher, and remain vigilant when positioning the filter. - Follow manufacturer instructions and guidelines regarding maximum weight and capacity limits to avoid overloading the crusher, which could increase the risk of crushing injuries or pinch points. - Use proper lifting techniques when positioning the filter, avoiding strains or sprains that could result from improper lifting or carrying heavy objects. - Keep the work area well-lit to reduce shadows and allow better visibility of potential hazards around the oil filter crusher. - Establish a two-person operation for larger or heavier filters to minimise strain from handling cumbersome objects and ensure crushing takes place promptly and effectively. - Conduct regular safety meetings to reinforce safe working practices and to address any concerns or incidents related to the use of the oil filter crusher, fostering a strong safety culture within the workplace.

			<ul style="list-style-type: none"> - Train all operators on proper working procedures in operating oil filter crushercontrols, focusing on safety measures to prevent electrocution and entrapment hazards. - Conduct regular safety briefings and refreshers emphasising key risks such as electrocution and entrapment, and ensuring that operators are aware of necessary control measures. - Install appropriate guarding around moving parts of the oil filter crusher to prevent accidental contact and entrapment during operation. - Ensure that all control switches and buttons are easy to reach and operate, reducing the need for operators to place themselves in hazardous positions while working. - Keep the workspace organised and free of any clutter, which could cause employees to slip, fall, or encroach into hazardous areas during operation. - Perform regular maintenance checks on the oil filter crusher and its components to identify any signs of wear or malfunction that could lead to hazards. - Develop and implement clear workplace policies and protocols for reporting and addressing hazards relating to electrocution and entrapment during oil filter crusher operation. - Provide personal protective equipment (PPE) such as gloves, safety glasses, or other barriers to protect operators from potential contact with electrical components or moving parts during operation. - Implement an incident review and reporting system to identify patterns and trends in hazards, enabling continuous improvement of safety measures and additional training as needed.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
