Ensure that all electrical connections are secure and properly insulated to avoid short-circuiting and electric shock during setup. Always wear personal protective equipment (PPE) such as rubber gloves, nonconductive shoes, and safety glasses when handling electrical components to reduce the risk of electrocution. Inspect the spindle moulder and related equipment for any visible signs of damage or wear-and-tear which could impact its safe operation, and report any issues before commencing work.
