If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

			<ul style="list-style-type: none"> <li>- Ensure that adequate lighting is available in the work area to easily see the transmission jack and the vehicle it will be supporting.</li> <li>- When positioning the transmission jack, always push or pull from the handle, not the body of the jack, to avoid strains and sprains.</li> <li>- Keep body parts clear of pinch points and crush points while positioning the transmission jack.</li> <li>- Always follow the manufacturer's guidelines for the maximum weight capacity of the transmission jack and never exceed it.</li> <li>- Position the transmission jack on a level and stable ground to prevent tipping or falling during use.</li> <li>- Secure all loose components of the transmission, such as hoses and wiring, to minimise the risk of falling objects when lifting or lowering.</li> <li>- Use additional wheel chocks or stands or jacks if required, as well as wheel chocks or other stabilising equipment to ensure the vehicle remains stable during transmission removal or installation.</li> <li>- Work with a partner or spotter who can help monitor the process and alert you to any potential hazards.</li> <li>- Communicate your actions clearly with others in the workplace to avoid confusion or miscommunication, which may contribute to incidents.</li> <li>- Follow proper ergonomic lifting techniques and use mechanical lifting assistance, such as a hoist or harness, whenever possible to avoid strain-related injuries when positioning the transmission jack.</li> </ul>		
3. Lifting	Crush injuries, Overloading	3H	<ul style="list-style-type: none"> <li>- Ensure all workers operating the transmission jack are properly trained and competent in its use, as well as aware of their surroundings while lifting.</li> <li>- Before lifting, thoroughly inspect the transmission jack for any signs of damage, wear or malfunction that could compromise its performance or safety.</li> <li>- Prior to operation, check the load capacity of the transmission jack and confirm that it does not exceed the maximum weight limit specified by the manufacturer.</li> <li>- Properly secure the load on the transmission jack using appropriate attachment points and lifting equipment, such as chains, straps or slings, to prevent shifting or falling during the process.</li> <li>- Maintain clear communication between all operators and workers in the vicinity, using hand signals or other agreed-upon methods, to coordinate safe lifting procedures.</li> <li>- Keep a suitable distance and establish exclusion zones around the lifting area to minimise the risk of crush injuries. This minimises the risk of overload and load imbalance.</li> <li>- Use qualified spotters to monitor the progress of the lift closely and ensure the load remains stable and properly aligned throughout the entire process.</li> <li>- Implement a regular maintenance schedule for the transmission jack to identify and address any potential problems before they worsen, which might lead to overloading or crushed-related injuries.</li> <li>- In case of an emergency, have evacuation plans and emergency response procedures in place, ensuring all workers are familiar with these protocols to quickly respond to unexpected hazards.</li> </ul>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
