Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, conditions and then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

			<ul style="list-style-type: none"> - Install appropriate guarding around all moving parts, particularly where fingers might become trapped during machine set-up processes. - Utilise lockout/tagout procedures whenever maintenance or repairs need to be carried out, ensuring that electrical hazards are properly managed. - Equip operators with suitable personal protective equipment (PPE) such as gloves, safety shoes, and eye protection to minimise potential risks associated with machine setup. - Always use designated equipment when interacting with and manipulating machinery components, rather than attempting manual adjustments. - Implement a well-defined maintenance schedule for the Turret Punch Press, including checking on electrical connections and looking for signs of damage, wear, or deterioration. - Use signage and warning labels to clearly mark all potential pinch points and electrical hazards associated with the machine. - Maintain a clean and organised work environment by keeping tools, equipment, and materials stored safely away from the immediate work area to eliminate clutter and other potential hazards. - Develop detailed standard operating procedures (SOPs) for machine set-up that outline each step and required precautions, making sure these are readily accessible to all workers. - Encourage open communication and reporting of hazards by nurturing a culture of safety among employees. Provide opportunities for operators and employees to voice their concerns and suggestions for improvements. - Regularly assess and review hazards and control measures associated with the machine set-up process and provide refresher training or additional controls as needed to ensure ongoing safety in the workplace.

			<ul style="list-style-type: none"> - Weight distribution: Ensure that materials are loaded evenly on the machine, so as to not create an imbalance which may lead to a loss of control and possible incidents. - Inspect equipment regularly: Regularly inspect equipment such as slings, chains, hooks, and forklifts used for material handling to ensure they are in good working order and have no visible defects. - Forklift safety guidelines adherence: When using a forklift, operators must adhere to all safe operating guidelines and only those with appropriate licenses and training should operate the machinery. - Restrict access to the loading area: Limit access to the Turret Punch Press material loading area to authorised and competent personnel only to minimise the risk of accidental injury by people who might be unaware of the hazards present. - Clean and well maintained work areas: Keep work areas clean, organised, and free of trip hazards to facilitate the safe and efficient movement of materials. - Provide appropriate signage: Clear signs should be posted around the workplace indicating hazardous areas, restricted access points, and relevant procedures for safe material handling while working with the Turret Punch Press. - Develop and enforce buddy system: Implement a buddy system where workers work in pairs throughout the material loading process, ensuring they are looking out for one another's safety while handling and loading materials onto the Turret Punch Press.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
